Prospective bidders should possess a similar contract with a value of 50 percent of the ABC. All phases of bidding process shall be governed by the Revised Implementing Rules and Regulations of RA 9184 (*The Government Procurement Reform Act*).

Bid documents will be available to prospective bidders upon payment of non-refundable bid fees to the Cashier's Office located at the 2nd Floor, Administration Building, RMSC, P. Ocampo Sr. Street, Malate, Manila during business days from 8:00 a.m. to 5:00 p.m.

- There is/are justifiable ground/s where the contract will not redound to the benefit of the government, without incurring any liability to the affected bidder/s
