The Philippine Sports Commission, through its Bids & Awards Committee, invites interested *accredited and eligible* contractors to apply for eligibility and to bid for the following:

Prospective bidders should possess a valid PCAB license applicable to the contract, have completed a similar contract with a value of 50 percent of the ABC, and have key personnel and equipment (owned, leased or under purchase) available for the prosecution of the contract.

The BAC will use non-discretionary pass/fail criteria in the eligibility check/screening as well as during the preliminary examination of bids. The BAC will conduct a post-qualification of the lowest calculated bid.

All phases of bidding process shall be governed by the Implementing Rules and Regulations of RA 9184 (*The Government Procurement Reform Act*). The complete schedule of activities is as follows:

7. Notice to Proceed	March 23, 2010

The BAC will issue bidding documents to prospective bidders upon submission and payment of non-refundable fees stated above for their Letters of Intent and similar payment of non-refundable bid fees to the Cashier located at the 2/F Administration Building, RMSC, P. Ocampo Sr. Street, Malate, Manila, during regular business days from 8:00 a.m. to 4:00 p.m.

The Commission reserves the right to reject any and all bids, or not to award the contract on the following grounds:

- There is prima facie evidence of collusion;
- The BAC failed to follow prescribed bidding procedures;
- There is/are justifiable ground/s where the contract will not redound to the benefit of the government without incurring any liability to the affected bidder/s.
