Pursuant to Section 2.7 of the Administrative Order (AO) 25 Inter-Agency Task Force on the Harmonization of National Government Performance Monitoring, Information and Reporting Systems Memorandum Circular No. 2019-2 dated 12 November 2019, Heads of Procuring Entities shall submit to the Government Procurement Policy Board (GPPB) a certification under oath on the compliance with Early Procurement Activities requirement on or before 31 January 2020.
